District Mission Statement

The mission of the Solana Beach School District is to provide a child-centered education of the highest quality, using the unique vision and resources of home, school, and community to ensure a stable and vibrant learning environment rigorous in academic standards, rich in diversity, sensitive to individuals, and committed to developing compassionate children who are confident, competent, and creative learners.

School Leadership

Leadership at Skyline is a responsibility shared among district administration, the principal, instructional staff, students, and parents. Decisions are based on the school's Site Strategic Plan. Principal Lisa Denham has led the school for five years, backed by 25 years of experience in education.

Staff members, parents, and students participate on various committees that make decisions regarding the priorities and direction of the educational plan to ensure instructional programs are consistent with students' needs and comply with district goals. School-level committees include: School Site Council, Student Council, Parent Teacher Association, Site Strategic Planning Committee, Character Education, Writing Task Force, and the Principal's Cabinet.

The Parent Teacher Association meets monthly to provide support for school programs and activities.

The School Site Council is an advisory group that meets monthly to address school programs, goals, and budget issues.

The Site Strategic Planning Team is composed of all advisory groups and provides a unifying focus for the school.

Discipline & Climate for Learning

Skyline School believes students who develop a sense of personal responsibility will mature both academically and emotionally. At the beginning of each school year, parents and students are informed of discipline policies at classroom and school orientations. Parents are informed of significant discipline issues. Two research-based programs, Second Step (K-2 and 6) and Steps to Respect (3-5), are implemented in all classrooms at Skyline to prevent bullying and to promote responsible, respectful student behavior.

The district provides a parent/student handbook for each of its sites which is supplemented by a set of behavioral standards developed by Skyline. The program's design establishes guidelines to provide students with a meaningful, productive, and enjoyable school experience. Appropriate behavior is encouraged through praise and motivational incentives, as well as assertive discipline and conflict resolution tools to further develop personal growth.

The Suspensions and Expulsions table displays the total number and percentage of incidents at the school and in the district. Suspension numbers may be inflated because some students may have been suspended multiple times. Expulsions occur only when required by law or when all other alternatives have been exhausted.

Professional Development

Staff members build teaching skills and concepts throughout the year by participating in conferences and workshops. Solana Beach School District offered one staff development day in the 2008-09 and 2009-10 school years, and two staff development days in the 2010-11 school year. Teachers are offered a broad-based variety of professional growth opportunities in curriculum, teaching strategies, and methodologies.

The main focus of staff development was on the Common Core State Standards for English/language arts and Mathematics and the essential differences between Common Core and the California State standards that have been used in the past. Other professional development topics included: Love and Logic®, Dreambox Learning, FASTT Math, and a presentation titled "Meeting the Needs of All Students".

Class Size

Class Size Reduction

In 1996, state legislature approved implementation of the Class Size Reduction (CSR) program that provides funding to hire additional teachers to assist schools in reducing K-3 class sizes. For the past three years, 100% of K-3 classrooms in the district participated in CSR.

Counseling & Support Services

It is important to the staff of Skyline to assist students in their social and personal development as well as academic growth. Qualified personnel provide counseling and support services on a full-time basis. The academic counselor-to-pupil ratio is 1:497. The following chart lists the support services offered to students at Skyline Elementary School.

Instructional Programs

GATE - The Gifted and Talented Education (GATE) program is offered to students in grades K-6 who have been recognized as capable of attaining high-levels of achievement by their teachers and identified through a variety of measures. Students in the GATE program receive differentiated instruction in their regular classroom from teachers who have been in GATE techniques.

At-Risk Intervention - Students in grades K-6 who are falling below grade level or performing below standards on assessments are targeted to receive specialized instruction in the areas of language arts and mathematics. This specialized instruction is delivered by the classroom teacher and through the assistance of support staff members. Skyline's reading specialist supports at-risk 4th-6th grade students using the state-adopted reading intervention program, Read 180. The Student Success Team meets regularly to evaluate and plan educational intervention for at-risk students.

English Language Learners - Skyline uses the Home Language Survey and California English Language Development Test to determine a student's understanding of and fluency in the English language. English Language Learners receive specialized services and instruction in an environment conducive to maximize English learning. Students may receive instructional support in the classroom or may be pulled out for specialized instruction aligned to English language development standards in language arts and focused on reading, writing, listening, and speaking skills.

Special Education - Skyline offers support as appropriate to meet student needs through the Individual Education Plan (IEP) process. Special Education services may be provided by a Resource Specialist, a Speech/Language Pathologist, an Occupational Therapist, and an Adaptive Physical Education Specialist. Skyline offers one regional Special Day Class for severely handicapped students. .

Curriculum Improvement

All curriculum at Solana Beach School District adheres to the California State Content Standards and Frameworks. Teachers align classroom curriculum to ensure that all students either meet or exceed state proficiency levels.

Instructional Materials & Textbooks

Solana Beach School District held a Public Hearing on September 15, 2011, and determined that each school within the district has sufficient and good quality textbooks, instructional materials, pursuant to the settlement of *Williams vs. the State of California*.

All students, including English Learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects for use in the classroom and to take home. Textbooks and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks used in the school the most current available. Materials approved for use by the state are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption. The table displays information collected in December 2011 about the quality, currency, and availability of the standards-aligned textbooks and other instructional materials used at the school.

Data Sources

Data within the SARC was provided by Solana Beach School District, retrieved from the 2010-11 SARC template, located on Dataquest (<http://data1.cde.ca.gov/dataquest>), and/or Ed-Data website.

Dataquest is a search engine, maintained by the California Department of Education (CDE), which allows the public to search for facts and figures pertaining to schools and districts throughout the state. Among the data available, parents and community may find information about school performance, test scores, student demographics, staffing, and student misconduct/intervention.

Ed-Data is a partnership of the CDE, EdSource, and the Fiscal Crisis and Management Assistance Team (FCMAT) that provides extensive financial, demographic, and performance information about California's public kindergarten through grade twelve school districts and schools.

Student Achievement & Testing

To obtain accurate and valid measures of educational progress, Solana Beach School District offers students multiple opportunities to demonstrate mastery of the California State Content Standards. In addition to district-established performance objectives, the state and federal governments have set standards for student achievement. A school's progress in meeting or exceeding those standards is measured through the results of testing and other criteria.

Federal Intervention Program

Schools and districts receiving Federal Title I funding enter Program Improvement (PI) if they do not make AYP for two consecutive years in the same content area (English/Language Arts or Mathematics) or on the same indicator (API or graduation rate). After entering PI, schools and districts advance to the next level of intervention with each additional year that they do not make AYP.

Academic Performance Index

The Academic Performance Index (API) is an annual measure of the academic performance and progress of schools in California. API scores range from 200 to 1,000, with a statewide target of 800.

Statewide and similar schools API ranks are published when the Base API is released each March. The statewide API rank ranges from 1 to 10. A statewide rank of 1 means that the school has an API score in the lowest 10 percent of all schools in the state, while a statewide rank of 10 means that the school has an API score in the highest 10 percent of all schools in the state. The similar schools API rank reflects how a school compares to 100 statistically matched "similar schools." A similar schools rank of 1 means that the school's academic performance is comparable to the lowest performing 10 schools of the 100 similar schools, while a similar schools rank of 10 means that the school's academic performance is better than at least 90 of the 100 similar schools.

The first table displays the school's statewide and similar schools API ranks and actual API point changes by student group for the past three years. The second table displays, by student group, the 2011 Growth API at the school, district, and state level.

Adequate Yearly Progress

No Child Left Behind (NCLB) is a federal law enacted in January 2002 that reauthorized the Elementary and Secondary Education Act (ESEA). It mandates that all students (including students who are economically disadvantaged, are from racial or ethnic minority groups, have disabilities, or have limited English proficiency) in all grades meet the state academic achievement standards for Mathematics and English/Language Arts by 2014. Schools must demonstrate "Adequate Yearly Progress" (AYP) toward achieving that goal. The Federal NCLB Act requires that all schools and districts meet the following Adequate Yearly Progress (AYP) requirements:

- Participation rate on the state's standards-based assessments in English/Language Arts (ELA) and Mathematics.
- Percent proficient on the state's standards-based assessments in ELA and Mathematics.
- API as an additional indicator.
- Graduation rate (for secondary schools).

There are several consequences for schools that do not meet the AYP standards, including additional tutoring and replacing of staff. Students would also be allowed to transfer to schools (within their district) that have met their AYP, and the former school would be required to provide the transportation to the new site. Results of school and district performance are displayed in the chart.

California Standards Test

The California Standards Test (CST), a component of the STAR Program, is administered to all students in the spring to assess student performance in relation to the State Content Standards. Student scores are reported as performance levels: Advanced (exceeds state standards), Proficient (meets standards), Basic (approaching standards), Below Basic (below standards), and Far Below Basic (well below standards).

The first table displays the percent of students achieving at the Proficient or Advanced level (meeting or exceeding the state standards) in English/Language Arts, Mathematics, Social Science, and Science, for the most recent three-year period. The second table displays the percent of students, by group, achieving at the Proficient or Advanced level (meeting or exceeding the state standards) for the most recent testing period.

California Modified Assessment (CMA)

California Modified Assessment (CMA) is an alternate assessment (a STAR Program component) that is based on modified achievement standards in ELA for grades three through eleven; Mathematics for grades three through seven, Algebra I, and Geometry; and Science in grades five and eight, and Life Science in grade ten. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations.

California Alternate Performance Assessment (CAPA)

California Alternate Performance Assessment (CAPA), a component of the STAR Program, includes ELA and Mathematics in grades two through eleven, and Science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations.

Physical Fitness

In the spring of each year, Skyline School is required by the state to administer a physical fitness test to all students in fifth grade. The physical fitness test is a standardized evaluation that measures each student's ability to perform fitness tasks in six major areas. Students that meet or exceed the standards in all six fitness areas are considered to be physically fit or in the "healthy fitness zone" (HFZ).

Safe School Plan

Student safety and campus security during the school day are of primary importance. All visitors must sign-in at the school's office and wear an identification badge while on school grounds. Teachers, instructional aides, and administrators provide supervision before and after school, during lunch, and during recess periods to ensure a safe and orderly environment.

The Comprehensive Safe School Plan was developed by the district to comply with Senate Bill 187 (SB 187) of 1997. The plan provides students and staff a means of ensuring a safe and orderly learning environment.

Each school includes the following requirements of SB 187 within their safe school plans: current status of school crime; child abuse reporting procedures; disaster procedures, routine and emergency; policies related to suspension and expulsion; notification to teachers; sexual harassment policy; provision of a school-wide dress code; safe ingress and egress of pupils, parents, and school employees; safe and orderly school environment; and school rules and procedures. The school evaluates the plan annually and updates it as needed. The plan was last updated and reviewed with school staff in August 2011.

School Facilities

Skyline provides a safe, clean environment for students, staff, and volunteers. Built in 1957 and modernized in 2000, Skyline School is situated on 10 acres. The school buildings span 48,534 square feet, consisting of 20 permanent classrooms, nine portable classrooms, a library, a staff room, a multi-purpose room, a computer lab, school office, health office, and a playground. The facility strongly supports teaching and learning through its classroom and playground space. The chart shows the results of the most recent school facilities inspection.

Maintenance and Repair

Safety concerns are the number one priority of Maintenance and Operations. District maintenance supervisors are proactive and conduct regular inspections at school sites. Repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service and emergency repairs are given the highest priority.

Cleaning Process and Schedule

The district governing board has adopted cleaning standards for all schools in the district. A summary of these standards is available at the school office or at the district office. The site administration team works with the custodial staff to develop cleaning schedules to ensure a clean and safe school.

Deferred Maintenance Budget

The district participates in the State School Deferred Maintenance Program, which provides state matching funds on a dollar-for-dollar basis, to assist school districts with expenditures for major repair or replacement of existing school building components. Typically, this includes the following:

- Roofing
- Heating/Air Conditioning
- Interior/Exterior painting
- Plumbing
- Electrical systems
- Floor systems

For the 2011-12 school year, the district budgeted \$230,000 for the deferred maintenance program. This represents 1.0% of the district's general fund budget.

Deferred Maintenance Projects

Deferred maintenance projects scheduled for this school in the 2010-11 school year include carpet replacement (2 rooms, fencing/landscape replacement, and minor exterior painting).

Expenditures & Services Funded

At the time this report was published, the most recent financial and salary comparison data from the State of California was for the 2009-10 school year.
