The Solana Beach School District will actively investigate all cases where it has reason to believe false information has been provided, including the use of private investigators to verify residency status. Verification may include home visits. _____

The District may refer cases in which false information has been intentionally provided under penalty of perjury to the San Diego District Attorney's office for further action and/or file a civil action to recover damages incurred as a result of providing false information.

Persons who provide false information under penalty of perjury are subject to criminal prosecution for perjury, which is punishable by a fine and/or a prison term of up to four years in state prison. (Family Code §6552; Penal Code §118,

125) _____

Persons providing false information under penalty of perjury also may be civilly liable for fraud, negligent misrepresentation, and negligence. Parties found civilly liable may be required to pay all damages caused to the District as a result of providing false information, as well as punitive damages. (Civic Code §1709)

Persons who induce, obtain or otherwise solicit another person to provide false information on an affidavit are subject to the same criminal prosecution, fines, and imprisonment as the person directly committing perjury. (Penal Code §127) _____

Investigations that reveal students have enrolled on the basis of providing false information will lead to disenrollment or withdrawal from the District.
