The 2020 triennial assessment requirements are: 1) comparison to a model policy; 2) progress with the LSWP goals; and 3) compliance with the policy. The structure of the assessments prior to 2020 is up to LEAs. For triennial assessments conducted 2020 and later, LEAs may choose their methods to meet the three requirements outlined above. One online tool recommended for model policy comparison is the Well SAT, which can be located on the Well SAT website. LEAs may use action planning documents containing timelines, goals, and tasks to assist in measuring progress and compliance with the policy, such as the School Health Index online tool located on the Center for Disease Control and Prevention website. LEAs must also make the results of the triennial assessment available to the public.

School Year: 2021-2022

Successes:

- Child Nutrition Services provided scratch lunch meals throughout the entire pandemic. Families had the opportunity to drive through and pick up meals.
- Social Emotional Learning strategies and practices implemented across the district in alignment with the CASEL competencies at all 7 school sites.

Barriers:

- Availability of large group events, community builders and school activities was reduced and restricted to align with California Department of Public Health (CDPH) health and safety guidelines due to the COVID-19 pandemic.
- With the availability of Immersive EDU, not all students had returned to a comprehensive school campus. This limited the access to live peer-to-peer interaction to strengthen social learning skills and strategies.
- CDPH required assigned seating, separation of 6 feet or more inside and outside of the classroom setting that limited students and their ability to self-select choices throughout the school day.

School Year: 2022-2023

Successes:

- Along with principals and school staff members, the Traveling SEL Team implemented a
 systematic framework that follows a progressive continuum for school sites to learn,
 practice, model and coach additional social, emotional and positive behavioral skills,
 practice them, and reinforce them; for all staff across all schools.
- Solana Beach School District contracted with Care Solace, a 24/7/365 Mental Health Care Coordination organization for all students.
- Certain CDPH restrictions were lifted, and this allowed LEA's to bring back select student programming/offerings and in person school based events resumed.
- Child Nutrition Services provided a total of 516,000 scratch meals (including breakfast and lunch).

Barriers:

- There is a need to consistently implement no food for birthday celebrations at all school sites, no student sharing of food and/or drinks.
- There is a need to consistently encourage school organizations to use health food items or non-food items for fundraising purposes.
- There is a need to educate students and families about the 5 components of school meals.

School Year: 2023-2024

Successes:

- Solana Beach School District's Employee Assistance Program (EASE) brings on a new partner, Evernorth Behavioral Health. This allows all staff members the ability to access mental health services and resources.
- Increased student awareness and engagement through Environmental Stewardship initiative:
 - o minimizing waste (share bins, recycling)
 - o understanding where and how our foods are grown
 - o utilizing outdoor and physical education
 - food recovery programs (providing nourishment for communities facing food insecurities)
- The Traveling SEL team provided ongoing opportunities for professional learning for classified staff to support student behavior.
- Continued to offer Care Solace to all students (mental health care coordination service)

Barriers:

- There is a need to educate students and families about the 5 components of school meals.
- Vacancies and turn over in food service positions districtwide.
