School Facility Conditions and Planned Improvements (Most Recent Year)

Solana Ranch provides a safe, clean environment for students, staff, and volunteers. Constructed in 2014, Solana Ranch has 34 classrooms on a 11.3-acre campus. The school consists of thirty (30) K-6 classrooms, two (2) special education classrooms, one library/media center, one art room, one music room, one computer room, one resource specialist area, one science/STREAM lab, one stage/multipurpose room, office complex, teacher preparation and tutoring/pull out rooms, day care facility, serving kitchen, hard court play areas, bus access, vehicle service drive and a parking lot with an 85 space parking capacity. School Safety Plan

Student safety and campus security during the school day are of primary importance. All gates are kept locked during the school day, and all visitors must sign-in at the school's office and wear an identification badge while on school grounds. Surveillance cameras, which are not actively monitored, are installed in each ingress and egress area. Teachers, instructional aides, and administrators provide supervision before and after school, during lunch and during recess periods. Development of the Comprehensive Safe School Plan is a collaborative effort between school and district to comply with Senate Bill 187 (SB 187) of 1997. The plan provides students and staff a means of ensuring a safe and orderly learning environment.

Each school includes the following requirements of SB 187 within their safe school plans: current status of school crime; child abuse reporting procedures; disaster procedures, routine and emergency; policies related to suspension and expulsion; notification to teachers; sexual harassment policy; provision of a school-wide dress code; safe ingress and egress of pupils, parents, and school employees; safe and orderly school environment; and school rules and procedures. The school evaluates the plan annually and updates it as needed. The plan was last updated and reviewed with school staff in September 2017.
