### School Facility Conditions and Planned Improvements (Most Recent Year)

Solana Vista provides a safe, clean environment for students, staff, and volunteers. Originally built in 1972, the school modernized classrooms and playgrounds in 2000 and 2001. Solana Vista is situated on 10 acres. The school buildings span 43,329 square feet, consisting of 9 permanent classrooms, 18 portable classrooms, a library, a staff room, a computer lab, a stage, and two playgrounds. In the summer of 2011, the school added three new relocatable classrooms, repaved both playgrounds, and installed Peaceful Playgrounds on both playgrounds. The facility strongly supports teaching and learning through its classroom and playground space. The chart shows the results of the most recent school facilities inspection.

We have a strong partnership with our Parent Teacher Association and the Solana Beach Schools Foundation, who provide substantial financial and volunteer support, including enrichment programs in STREAM (Science, Technology, Research, Art, and Math) and Physical Education. In addition, Solana Vista has a very active ELAC (English Learner Advisory Committee) that meets quarterly to provide training, resources and support to families of our English learners.

### School Safety Plan

Student safety and campus security during the school day are of primary importance. All gates are kept locked during the school day, and all visitors must sign-in at the school's office and wear an identification badge while on school grounds. Surveillance cameras, which are not actively monitored, are installed in each ingress and egress area. Teachers, instructional aides, and administrators provide supervision before and after school, during lunch and during recess periods. Development of the Comprehensive Safe School Plan is a collaborative effort between school and district to comply with Senate Bill 187 (SB 187) of 1997. The plan provides students and staff a means of ensuring a safe and orderly learning environment.

Each school includes the following requirements of SB 187 within their safe school plans: current status of school crime; child abuse reporting procedures; disaster procedures, routine and emergency; policies related to suspension and expulsion; notification to teachers; sexual harassment policy; provision of a school-wide dress code; safe ingress and egress of pupils, parents, and school employees; safe and orderly school environment; and school rules and procedures. The school evaluates the plan annually and updates it as needed. The plan was last updated and reviewed with school staff in September 2017.
